# Indicative Fees Guide

Care fees in a Quantum Care home are based on a range of factors including the levels of individual care you require and the size and facilities of the room you have chosen.

The fees for Melwood Grange are as follows:

## Weekly Fees for Self Funders

- Residential Care – from £1,450 per week
- Dementia Care – from £1,500 per week
- Nursing Care – from £1,650 per week excluding FNC

These fees are subject to a pre-admission assessment, where we will plan the level of care and support you require to meet your needs. Your assessed fees will then be discussed and confirmed with you before you accept your place at the home.

## What's included in your Weekly Fees

- Personal care
- Accommodation in a room for your sole use and use of the communal areas in the home
- All meals, snacks and soft drinks
- Heating, lighting and hot water
- Bed linen and towels
- Laundry (excluding dry cleaning)
- Some outings/entertainment
- Central administrative and management services such as staffing, administration, maintenance of the buildings, furnishings and all other overhead expenditure

## What's not included in your Weekly Fees

- Toiletries and personal items
- Clothing
- Dry cleaning
- Clothing labels and labelling of clothes
- Hairdressing
- Transport
- Telephone calls
- Insurance of valuables
- Newspapers and sweets

- Some outings/entertainment
- Private health services such as Chiropody or Dental Care
- Continence aids not provided by the Health Authority
- Television subscriptions (and television licence if required)
- Being escorted by staff to appointments and the cost of transport to those appointments
- Storing your items and personal belongings after you have left the home
- Any other items or services not included in the fees

## Confirming your Admission

In order to confirm your place at the home, you will be asked to provide details of your capacity to fund your stay for a minimum of one year.

You will also be required to pay:

- Four weeks' deposit which will be held by us for the duration of your residence at the home
- Four weeks' advance payment of your care home fees

## Review of Care Fees

### Change in Care Needs

We will regularly monitor and review the care and support you require and if your needs change this may affect your care fees. Should we feel that your fees need to be changed, then we will discuss this with you and/or your representative before any change is agreed. ### Annual Review of Fees
